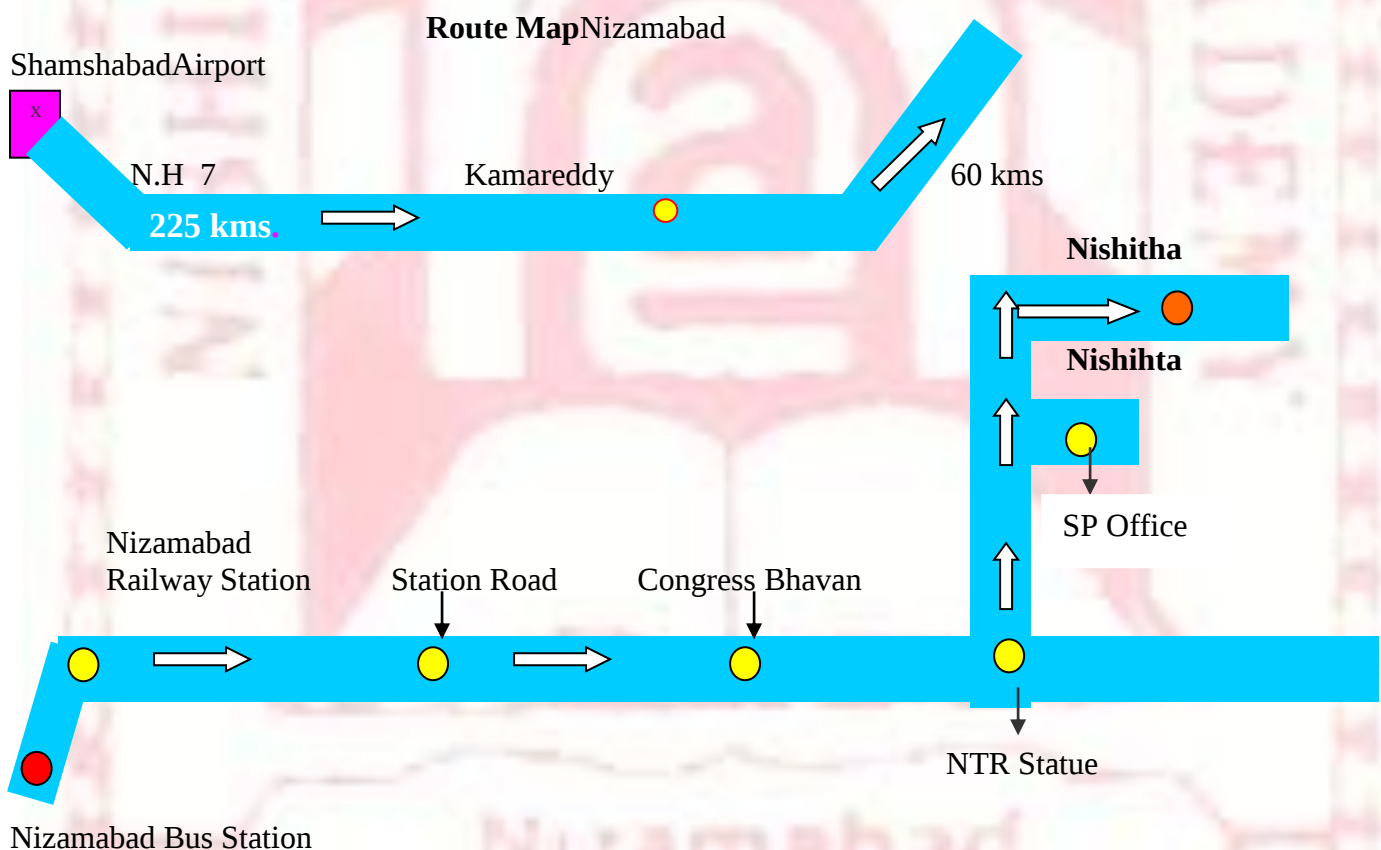

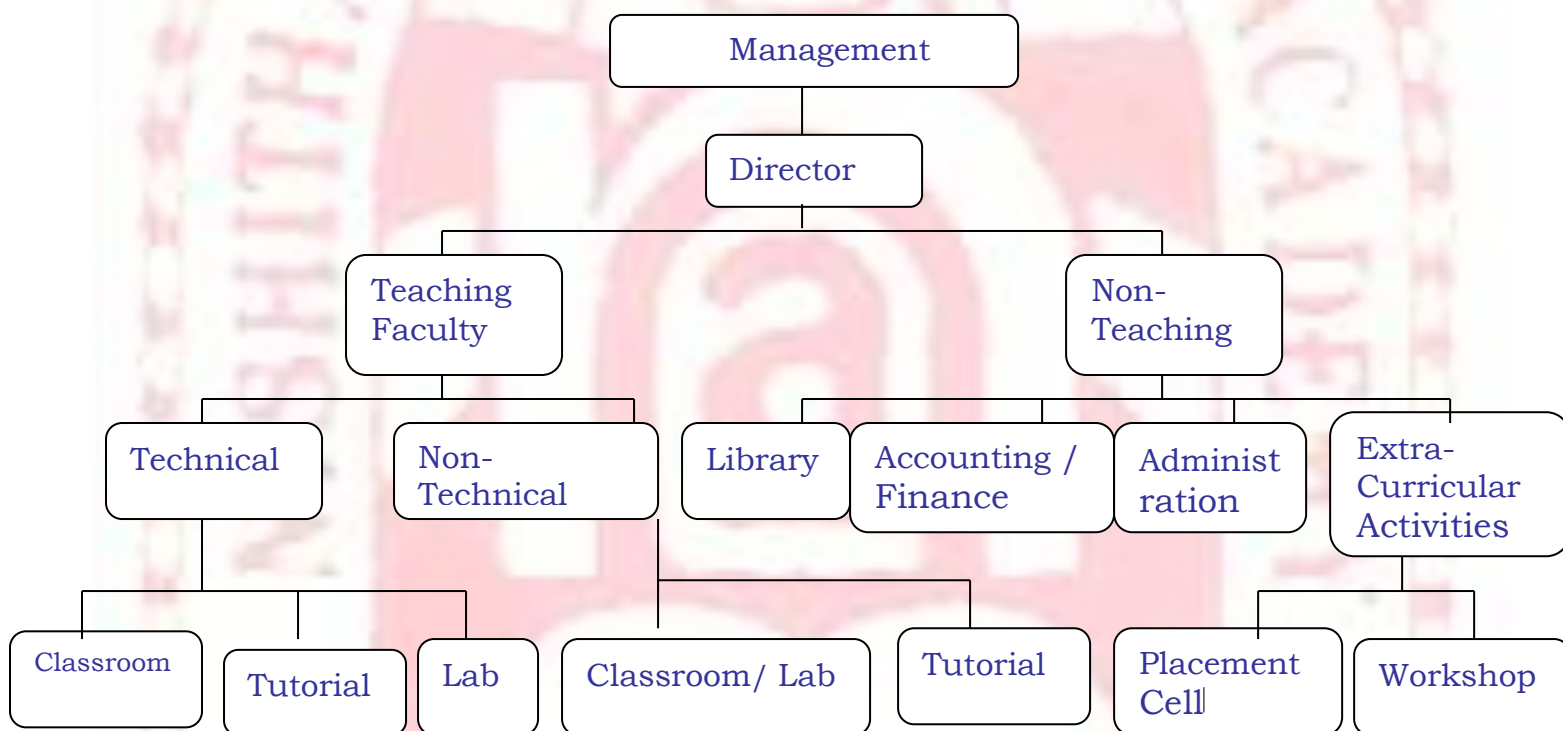

E.NATURE AND EXTENT OF INVOLVEMENT OF FACULTY AND STUDENTS IN ACADEMIC AFFAIRS/IMPROVEMENTS

Initiatives taken to inculcate the spirit of research amongst faculty and students are as follows:

- In-house development of both lab equipment and software

• **Community Engagement - Extra Curricular Activities**

The institute believes that we have a responsibility towards society and that technology should be brought to the use of community. National Social Service (NSS) activities make students responsible towards society, environment, global issues, etc and develop into responsible citizens.

• **Human Resource Management**

Nishitha Degree College management believes that faculty and staff are the backbone of the institute and that its success depends on the quality of human resources. Therefore, the objectives of human resource management are focused on maximizing employee performance. Priority is given for recruitment of suitable, competent faculty, training them to meet their teaching objectives, helping them realize their potential, rewarding high performing faculty and counseling low performing faculty based on their performance appraisal. In addition,

- Training is arranged for teaching as well as nonteaching staff by identifying training needs, for enhancing professional competencies, teaching and soft skills
- Service rules are transparent and benefits like Provident Fund, Gratuity, Group Insurance Scheme, Mediclaim etc. are provided to employees
- The institute arranges financial planning lectures for staff, to assist them for effective planning of their finances
- The institute arranges lectures for staff, to assist them for effective stress management and health
- Institute implements a variety of welfare schemes for teaching and non-teaching staff

•Industry interaction

As part of the quality improvement strategy and to bridge the gap between academics and industry, the institute has established an Industry-Institute Interaction cell. Regular interaction with the industries is established through meetings, guest lectures, internships, projects and industrial visits.

In order to enhance industry interaction the following strategies are implemented:

- Departments to appoint industry coordinator who will interact with the industries by approaching local industries: to understand their expectations in terms of knowledge and skill requirements in a graduating engineer
- To identify and invite industry experts to deliver content beyond syllabus and make students aware of contemporary issues and engineering practices adopted in the industry
- •To provide industry exposure to students through internships in industry, industry visits and enable them to pick up skills besides what is being imparted in the classrooms
- In order to understand industry needs the cell hosts an HR meet every year. The meet involves lectures/interactions with eminent industrialists, panel discussions between students, faculty and industry experts which gives invaluable insights of the placements scenario and recent developments at local and global levels that serve as an input for identifying training needs of our students in order to make them employable

F. MECHANISM/ NORMS AND PROCEDURE FOR DEMOCRATIC/ GOOD GOVERNANCE

The management recognizes the need for decentralization for the growth of the institute and accords with the level of management. Heads are appointed who are given autonomy for efficient governance.

The roles and responsibilities of administrators / decision makers for various assigned jobs listed below clearly depict the delegation of authority, providing operational autonomy leading to a decentralized governance system.

•Principal

•Head of the department

HOD is responsible for the academic and administrative functions of the department. In addition, Registrar, Accounts Officer, Librarian, Workshop Superintendent take care of office related activities, finance related issues, library resources and workshop related activities.

At the department level:

- Each program has coordinators
- Preparation of academic calendar based on time frame set by the University for planning and organizing of activities is done by Time Table co-ordinator
- Each course has a course co-ordinator who, in consultation with the faculty teaching the subject, sets course objectives, prepares the teaching plan for the semester, conducts meetings with faculty regularly to monitor and review course completion and attainment of course.
- Class teachers/batch guardians are designated for all classes/batches

G. STUDENT FEEDBACK MECHANISM ON INSTITUTIONAL GOVERNANCE /FACULTY PERFORMANCE:

- Feedbacks from students are taken every semester and at the end of every year regarding the performance of faculty, administration and other concerned activities. The feedback data is analyzed and suitable modifications or improvements made / incorporated for improving the overall efficiency are introduced.
- Feedback from students in the form of filled in forms is periodically taken by Heads of Departments of all branches regarding the faculty performance as well as other problems or inconveniences that students are likely to face in the day to day run of the institution.
- A panel of members consisting of Secretary, Principal and H.O.Ds look into the analysis of the feedback thus received, and inform the teachers of their performance in private. Appropriate suggestions, if any, are given to them accordingly.
- An annual review by members of Management and Principal is undertaken to discuss about more effective ways of administrative procedures. Based on feedback and other important factors like parental opinion, plans for further expansion of the institutional establishment etc., recommendations are made and decisions taken towards upgrading institutional governance.

As per the AICTE notification, dated 25.05.2012 regarding establishment of Mechanism for Grievance Redressal Regulations, 2012. This notification is meant to ensure transparency in admissions by Technical Institutions imparting Technical Education. The paramount objective of the AICTE Regulations 2012 is to prevent unfair practices and to provide a mechanism to innocent students to get their grievances redressed.

As per the AICTE Regulations 2012 every Technical University has to appoint an Ombudsman for redressal of grievances of innocent students. The Ombudsman has to be appointed by the University on a part time basis.

The Ombudsman has specific powers and functions to redress a variety of grievances of the students against the University or Institution. Such as, admission to a course and any discrimination in evaluation. The Ombudsman has powers to take the assistance of any person belonging to SC, ST and BC, Minority or Disabled Categories for hearing complaints.

In view of the above, the Vice Chancellor is pleased to appoint Prof. D. Chennappa, Professor, Department of Commerce & Business Management, Osmania University, Hyderabad as Ombudsman for MBA and MCA Colleges affiliated to Telangana University as per AICTE guidelines for a period of one year.

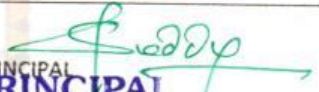

Internal Continuous Evaluation System:

The college will have a committee for examination headed by the Principal and supported by Vice Principal of the three faculties. The College Exam Authority will be assisted by a team of senior teachers. The committee will conduct internal and external examinations for all the programmes. The Choice Based Credit System will be continued with continuous assessment in the form of different activities like internal external exams, objective type questions, MCQs presentations and group discussions. 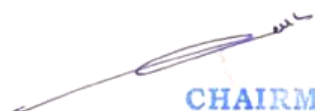
